What you should know
about corruption

CORRUPTION - the abuse of power, bribery, bribe-taking, abuse of authority, commercial bribery or other illegal use by a natural person of his or her official authority contrary to the legitimate interests of society and the state in order to obtain benefits in the form of money, valuables, other property or property-related services, other property rights for themselves or for third party, or illegally making available of such benefits to specified person by other individuals, as well as the commission of these acts on behalf of or in the interests of the legal entity.

THE PUNISHMENT FOR RECEIVING A BRIBE (Article 290 of the Criminal Code of the Russian Federation)

Imprisonment for a term of eight to fifteen years with a fine of up to seventy times the amount of the bribe or without it and with the deprivation of the right to hold certain positions or engage in certain activities for a term of up to fifteen years.

PUNISHMENT FOR GIVING A BRIBE (Article 291 of the Criminal Code of the Russian Federation)

Imprisonment for a term of eight to fifteen years with a fine of up to seventy times the amount of the bribe or without it and with the deprivation of the right to hold certain positions or engage in certain activities for a term of up to ten years.



IF YOU ARE ASKED FOR A BRIBE. YOUR ACTIONS?

DO NOT OFFER OR GIVE A BRIBE!

Otherwise, you will commit a crime yourself (article 291 of the Criminal Code of the Russian Federation). Listen to the extortionist's demands to contact the police.

BEFORE YOU WRITE AN APPLICATION...

Remember that reporting a fictitious fact of extorting a bribe is a criminal offense. Knowingly false denunciation is punishable by a fine, forced labor, or imprisonment for up to three years. If it is proved that the evidence is artificially created, then the term of imprisonment may be increased to six years (article 306 of the Criminal Code of the Russian Federation).



HOW DO I BRING AN EXTORTIONIST TO JUSTICE?

You will have to go to the nearest police station and write a statement.

You can make a statement about the crime in oral or written form. You must sign a written statement about the crime. Specify the postal or email address where the response should be sent.

An oral statement of the crime is recorded in the protocol, which is signed by you and the employee who accepted the statement. The protocol must contain information about you, as well as your identity documents.

You will be warned of criminal liability for knowingly false denunciation in accordance with article 306 The Criminal Code of the Russian Federation, about which a note will be made in the protocol. Sign it.

When registering an application, you must receive a notification ticket, which indicates the serial number of the application in the book of reports of crimes and the date of its acceptance. You will have to go to the nearest police station and write a statement. you will receive a response.
